#### Other Business:

1. Review proposed zoning, erosion and sedimentation plan, agritainment and parking ordinance changes/additions.

Zoning – Low Impact Home Based Business – Motion by Patti Fenstermacher, seconded by Teena Bailey to add 100% of floor area but remove whichever is less of the garage or accessory building. Motion carried.

Zoning – Under definitions – Accessory Apartment – Motion by Mark Steidinger, seconded by Dillion Turner to approve with changes as noted: allow in all zoning districts, remove section regarding occupants shall be related, and Chris Noll will offer rewording of section (2) regarding septic system. Motion carried.

Parking Ordinance 2015-2 – Motion by Mark Steidinger, seconded by Teena Bailey to approve with changes noted: change references to "parking officer" to "enforcement officer", remove definition of parking officer, change "shaded" to "in red" when referencing Exhibit A, change name of Exhibit A from "No Parking" to "Parking". Motion carried.

Motor Vehicle and Traffic 15-101: Motion by Teena Bailey, seconded by Mark Steidinger to remove sections 15-701, 702 and 703. Motion carried. Motion by Brian Alnutt, seconded by Priscilla Brennan to remove sections 15-802 and 803 and correct the road names listed in 804, change reference to fine as fees set by resolution. Motion carried.

Erosion and sedimentation control plan - Motion by Priscilla Brennan, seconded by

Mark Steidinger to use the sample ordinance from Lowhill Township with changes as noted: section 5. 2. Replace "attractive" with "non-invasive", 5.3. remove "in an unsightly fashion nor", 6.A. replace "Township Administrator" with "Township", 7.A. replace "Administrator" with "Township" in 2 places, 9. correct "sentences" to "sentenced", have Atty. Waters give his opinion on the wording of section 9. Penalties. Motion carried.
