## Plan Review New Business:

Snyder – Buckery Road – Minor Subdvision – Feasibility Plan and Sewage Planning Module – Greg Snyder represented the plan. Greg Snyder requested the sewage planning module be placed on the August Board of Supervisors meeting to be reviewed.

(11) add the wording "by the number of available parking spaces" to the end of sentence after "exceeded". Add (12) to (17) as written but change ordinance section reference in (14) to comply with our ordinance. (18) change 28 days to 30 days. (19) and (20) as written. (21) change 300 to 100 vehicles per day. (22) to (24) as written. (25) change the first 'may" to "shall" and change "patrons travelling" to "over 100 vehicles traveling". Change "may" to "shall" in the second sentence. Add "for over 100 vehicles" after traffic-control personnel. (26) as written. (27) change "the Planning Director" to the title of the designated person agreed to by Supervisors. The PC members ask that the township solicitor review the wording for (27). Motion by

Mark Steidinger, seconded by Priscilla Brennan to accept the Upper Macungie ordinance including the changes as noted in the discussions by the planning commission. Motion carried.

3. Review changes to zoning ordinance supplemental regulations regarding height of accessory structures. PC members tabled until next meeting.
